#### **TERMS AND CONDITIONS**

- (a) The articles are to be supplied to the Cochin Port Trust Hospital daily/alternate days before 3.30.P.M.
- (b) The articles must be supplied at their own cost in the Hospital in such quantities as required by the Chief Medical Officer, Cochin Port Trust from time to time.
- c) An indent for daily/alternate days will be given to the suppliers, and the supplier or any of his representatives should collect the indent from the office of the Chief Medical Officer.
- (d) The dietary articles to be supplied should be of first class quality without any defects.
- e) The vendor may quote the maximum % of discount on the market rate of items supplied and the bidder who quotes maximum discount will be selected.
- (f) Payment will be made fortnightly (consolidated bill) by NEFT/RTGS drawn in favour of concerned firm.
- (g) The GST complaint invoice should be submitted for payment.
- (h) Articles not confirming to the specification will not be accepted.
- (i) The items required are enclosed.(Annex-I)
- (j) Cost of tender documents Rs.**2000**/- & Earnest Money Deposit(EMD) **Rs.9,000**/-including GST are to be remitted in the form of Demand Draft /Banker's cheque issued by Nationalized/Scheduled banks, drawn in favour of the FA& CAO, Cochin Port Trust, payable at Cochin as two separate DD/Banker's Cheque.
- (k) The successful bidder shall submit an amount of **Rs.10,000**/- (Rupees Ten thousand only) in the form of DD in favour of F.A & C.A.O., CoPT, as interest free Security Deposit for the fulfillment of the contract, which will be refunded at the end of the contract period.
- l)The successful contractor will be required to execute an agreement in Stamp Paper of appropriate value, at his own expenses in the prescribed form within 7 (Seven) days of the acceptance of the tender.
