## NOTICE INVITING BUDGETARY INQUIRY

## BACK GROUND.

Cochin Port Authority have undertaken the project "Re-Construction of North Jetty for Indian Navy at Naval Base, Kochi " on deposit work terms and the project is expected to be completed by October, 2024.

The said Jetty is located along Ernakulam channel opposite to Port's Tanker berths (Location Plan at *Annexure-I*). Now, CoPA intends to carry out Capital dredging of the approach channel and jetty basin to a depth of (-)10m CD using suitable Dredger(s). The sounding chart showing the proposed area of dredging is at *Annexure-II*. The approximate quantity of dredging is about 10.00 lakh m³ (9.0 lakh m³ at Jetty frontage and 1.00 lakh m³ at lee side and under the Jetty).

The un-usable dredged material shall be conveyed and disposed off in the specified dumping area. Two dumping areas are one on south and the other on the north of approach channel is shown in *Annexure-III*. These dumping areas are approximately 12.999 km located at 295° 57′ 16.8″ and 11.797 km located at 236° 24′ 47.2″ from No.7 and No.8 buoys respectively. The dredged material may be dumped predominantly at the south dumping area and north dumping area may be used only when there are hindrances for accessing the southern dumping area. The material shall be dumped only beyond the distances specified above and where water depth is 20m or more, spreading evenly over an area having a diameter of 3 km, in such a way that the depth shall not be less than 19 m at any time.

Port is in the process of preparing the detailed estimate for the Capital Dredging work. It is proposed to invite tenders for the work shortly and the period of contract will be about 6months. In this regard, you are requested to furnish your budgetary rates for the items attached at Annexure-IV. GST may be shown separately. No mobilization and demobilisation charges for dredger(s) will be paid extra and the rate shall cover both mobilization and demobilisation charges of dredger(s).

The bidders are requested to submit the <u>Budgetary rates</u> as per *Annexure-IV* attached and may be sent in sealed cover superscribing "Budgetary Rates for the "Capital dredging for the manoeuvring the basins of Indian Navy North Jetty at Naval Base, Kochi", to the Chief Engineer, Cochin Port Authority at the address given above (e-mail: <u>ce@cochinport.gov.in</u>; coptce@gmail.com) so as to reach us on or before **07-10-2022 at 17:00 hrs.** 

The bidders may note that the rates are invited only for **budgetary** purpose. Cochin Port is not bound to award the work to any bidders based on the **budgetary** rates submitted. Cochin Port Trust will not be liable for any financial obligation to the bidders in connection with the preparation of their budgetary rates.
