- 1. The quotation No. & date may be super scribed on the envelope.
- 2. All lines items in the RFQ shall be quoted by the vender. Otherwise quotation will be rejected.
- 3. The Grand total amount excluding GST will be considered for price evaluation.
- 4. PESO certification for tested Extinguisher cylinder shall be provided.
- 5. Pressure Testing and Refilling has to be done as **per IS 2190** (Selection, installation, and maintenance of Fire Extinguishers)
- 6. The transportation of the cylinders to your yard in and around Cochin and back to CoPA shall be done by CoPA at our cost and risk.
- 1. The work shall be carried out as per the quality standards and to the entire satisfaction of CFO, CoPA.
- 2. Any defect/damage found in the attended work shall be rectified by the contractor at his sole risk and cost.
- 3. Income tax applicable at the prevailing rates will be deducted at the time of payment.
- 4. GST will be paid additionally by CoPA as applicable against relevant GST invoice addressed to the undersigned.
- 5. Work should be completed within 14 days from the date of arrival of extinguishers at your site.
- 6. 100% payment will be made on satisfactory completion of entire work and issuance of PESO certificate. A satisfactory work completion certificate/ invoice certified by the Chief Fire Officer, CoPA shall be submitted for releasing payment.
- 7. Legal jurisdiction of the contract shall be Cochin City only.
