  - a) The work should be carried out neatly and promptly to high standards of printing quality and completed within one week of the work order along with the matter.
  - b) The book containing in between 50 to 60 pages in each version.
4. Photocopying 120 (6 pages x 20 sets) copies of Review of Accounts of Audit Report for the year 2023-24 (English & Hindi version) - Per page rate.
