Restructuring vide Ministry Guidelines contained in letter I-26/7/2015 PE-I

Sir

As part of the subject policy guidelines , Skilled Professionals and Experts who can assist the top management in improving the operational capacity of the Ports were inducted by all major Ports . The objective of such induction was to re-vamp the organizational matrix of the Ports to meet the international bench marks of Port Efficiency and Port Profitability. Regular Port Officers were invited to join as professional functionary on contractual basis after resignation from Port Service. Professional Functionaries were engaged by the Ports in the Pay scale of Chief Manager (Rs 36600 to Rs 62000) , Senior Manager (Rs 32900 to Rs 58000) , Manager (Rs 29100 to Rs 54500) .

In view of the above , following information is requested.

- (1) Is there any Nodal Officer in the Ministry / IPA to (1) take feedback from Professional Functionary who are working presently / had left from Port , (2) to clarify queries of Professional Functionaries engaged by Port. Name and Contact details of Nodal Officer may please be shared , if any .
- (2) Names , period of contractual engagement , Designation etc. of Professionally functionaries engaged contractually by different Ports , as per above guideline, may please be shared , if available with Ministry / IPA .
- (3) Is such contract between Professional Functionary and respective port is renewable after complying all the terms and conditions by Professional Functionary with "very good" performance grading during the period of engagement
 - (a) In the case of regular port officers who resigned from regular service and joined on contract as professional functionary and completed the tenure. Relevant guideline may please be shared in this regard.
 - (b) In the case of other than regular port officers who completed the tenure. Relevant guideline may please be shared in this regard.
- (4) Subject Guideline letter and its subsequent amendment / addendum may please be shared.
