
Sub: Information sought under RTI Act 2005

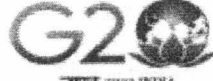
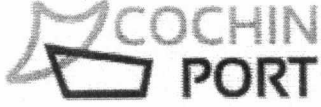

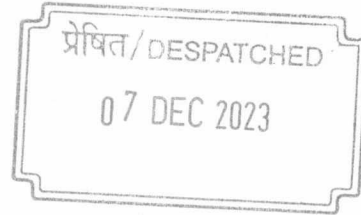
