Trade Notice No.16/2021

Sub: Rebate on Vessel Related Charges for container vessels at ICTT.

In continuation of the Trade Circular No. FD/Costing/Concession/VRC/ICTT/2020 dated 22.12.2020 and Trade Notice No. 02(a)/2021 dated 15.03.2021, the Competent Authority has approved to extend the validity of the existing concession scheme of the following rebates in Vessel Related Charges for container vessel calls at ICTT upto 31.12.2021.

Sl. No.	Concessions
1.	Rebate on VRC for Mainline Container Vessel Calls (ad-hoc) connecting any port of call defined for Mainline Services by the same operator (Not applicable for Mainline Container Vessel Services).
2.	Rebate on VRC for Feeder Services to Foreign Destinations, other than Colombo, and not connecting Colombo, either directly or via Tuticorin.
3.	Rebate on VRC for feeder services to Bangladesh either directly or via any Indian Port.
4.	Rebate on VRC for Coastal Feeder Services to Visakhapatnam, Kolkata and Haldia.
5.	Rebate on VRC for Feeder Services to Foreign Destinations, other than Colombo, irrespective of the connectivity between Cochin and Colombo.
6.	Rebate on VRC for Feeder Services between Cochin and the Middle East with Weekly Double- Dipping Calls.
7.	Rebate on VRC for foreign and coastal vessels handling 100 or more TEUs of Exim transshipment containers per call.
